The Department of International Relations, International Information and Security, School of International Economic Relations and Tourist Business, V. N. Karazin Kharkiv National University, welcomes you to participate in the Roundtable Discussion ‘**European Diplomacy in the 21st Century**’ that is a part of the Jean Monnet Module ‘The Foreign Policy of the European Union’ funded by the European Commission.

We invite submissions from scholars, practitioners and students whose research interests are related to the roundtable topics.

THE SCOPE OF THE ROUNDTABLE

The Roundtable envisages a discussion on the new challenges facing European diplomacy in the 21st century with the focus on the following issues (the list is not exhausted):

1. The role of European diplomacy in providing the global peace and security.
2. Innovation in diplomacy and information security.
3. Between cooperation and competition: problems of economic diplomacy.
4. ‘Traditional’ diplomacy vs. new forms of diplomacy (cultural, scientific, academic, people and other forms of ‘short-sleeves’ diplomacy).
5. Diplomatic relations between EU and Ukraine: current state and prospects.

The working languages of the Roundtable are Ukrainian, English and Russian.

Form of participation: abstract submission or/and presentation (you may submit a paper without attending the Roundtable and participating in discussion, if you'd like, but you must submit a paper to participate).

The Roundtable papers collection will be published after the event.

The Roundtable Committee selects papers for publishing based on their originality, novelty, elegance, theoretical and practical impact.

SUBMISSION GUIDELINES

In order to participate in the Roundtable, please email to **l.novikova@karazin.ua** application and paper in Ukrainian, English or Russian language up to 6 pages which meet the formatting requirements (see below).

In addition, the authors without PhD are asked to submit a scanned copy of letter from their supervisor or an extract from the protocol of their department (school) meeting with recommendation for publishing.

The deadline for submission is December 15, 2018.

FINANCIAL ISSUES

Participation in the Roundtable is **free of charge** with no administration fee.

All expenses related to organization of the event and publication of the papers collection are covered by the Jean Monnet Module grant from the Education, Audiovisual and Culture Executive Agency of the European Commission.

FORMATTING REQUIREMENTS

Only papers related to the roundtable topics are accepted.

File types: Word or RTF.

The file's title should include an author's name (Ivanenko_paper.doc or Ivanenko_application.doc).

Page limits: max 6 pages (including references)

Your paper file must adhere to the following formatting requirements:

do not number the pages or include line numbering;

the main text must be in single-column format, 1,5 spaced, in Times New Roman 14 font;

the manuscript must be left justified;

nothing should be underlined;

there should be no endnotes.

A paper should use in-text citation. A direct quotation should include the number of a source in the list of references and the page number, for example [2, p. 65].

The list of references should be provided after the main body of text (rubric 'References'). The list of references should be indexed (1,2,3...) and use OSCOLA style for the bibliographies.
