RESULTS IN GENERAL

Integration of research, HE, business

- 1. The best practices in commercialisation of innovations by universities in EU have been analysed and summarised.
- 2. Graduates in the Ukrainian universities involved are better equipped to be able to facilitate interaction of academia and innovations-intensive business.
- 3. Recommendations on the improvement of legislative basis for commercialisation of innovations have been delivered.
- 4. Mechanisms and a framework for commercialisation of innovations by universities in collaboration with other stakeholders have been delivered and verified in practice.




INSTITUTIONAL LEVEL

- Human resource familiar with legal, pedagogical components of innovations/commercialisation (2 study visits, 10 representatives from each HEI to visit
- Poland, Portugal, Sweden, UK) and coached Help-desks for technology transfer are established in 4 universities in Ukraine
- Regulation on the Commercialization of Innovations are developed and approved

REGIONAL AND NATIONAL LEVELS

Regionally

- Round tables with stakeholders are put into practice (yearly basis)
- Students' business *projects competition* put into practice (yearly basis), 16 business projects presented, teams coached by help-desks in collaboration with local SME and EU stakeholders in 2015

Nationally

- Model of the Regulation on the Commercialization of Innovations by HEI has been developed and disseminated via the web-site of the Ministry of Education and Science of Ukraine
- Proposals for new Law on HE (submitted in Spring 2014 for Parliamentary hearings)
- Concept for support of development and commercialization of innovations by HEIs in UA
- **Methodological recommendations** for the updating of engineering and economics education towards the enhancing effectiveness of commercialization of innovations
- **Analysis** on the Applicability of the "Model intellectual property policy for universities and research institutions" (offered by WIPO) in Ukraine has been developed

CHALLENGES AND PROBLEMS

Transition of the HE context in Ukraine during the project's lifetime from "we need new supportive legislation to do something" to "how and what to do in the new legislative environment" changed our focus to more practical issues:

- -to work out the procedures,
- -to put into HE practices of new services/activities,
- -to find the ways to engage with stakeholders
