Note: we submitted application with more staff stays (4 from UA + 4 from SK) stays and student (5+2 = 450+120 days) stays from Ukraine, but our university received **about 40 % of planned finance for approx. 33 % of planned number of stays** (staff 1 from UA + 1 from SK; students 1+1 = 150+60 days). = Good plan of mobility number!!!

#### **Preparation of ERASMUS+ project with UKRAINE**

- For project preparation we need from you number of motilities (staff/students);
- process about selection of students, ...;
- information about study subjects at your university; your website with course catalogue;
- guarantee that if we win a project, you will post information about project and cooperation with our university on the website and also inform about our visits to your website = we declare it in the project proposal, where there will be outputs and what;
- outputs can be common research publication, common utilization of test machines etc. .....;
- PIC code, ..... complete information about contact person, ..... and intensive communication !!!

#### **STUDENTS FROM SUMY TO PÚCHOV**

#### **BEFORE STAYS** (- 2 months before stays)



 selection and nomination of students for study, SUMY send all information about student with copy of passport 1) we prepare Invitation letter in Slovak (from - to, Erasmus finance xx Eur, information about address of accommodation) with the our Rector's signature. Not to use the word **mobility** because the word mobility is not recognized by the Foreign Police at Slovak Republic (mobility = for the Foreign Police it is the arrival of a student from another Member State of EU, where student has a residence permit, to study at Slovakia). Use the word Erasmus + study stay.

Be careful Y/I (name as passport name) ! E.g. Zhylinski in passport / Zhilinski in other personal cards.

**BEFORE STAYS** (- 1 month before stays)

2) student, SUMY and Púchov coordinators: Learning
Agreement with subjects and credits and signatures.
(help to student)

3) student must be send us number of bank account (IBAN, SWIFT) in EURO !

**4)** we: **Financial agreement** with the Slovak Rector's signature. After student send proof of purchase of the boarding pass (its scan via email), the university send money to student bank account (about three weeks before stay).

**5)** we: Book accommodation. student: Book an appointment at the Alien Police in advance (via online system, possible before coming to Slovak Republic, one month ago)! <sup>12</sup>

#### **BEFORE STAYS**

6) student: The translation of the extract from the criminal record for the Alien Police for the purpose of obtaining temporary residence should be done after entering the Slovak Republic in a certified translation agency in Slovakia or at Slovak Embassy in Ukraine (the translation must be fitted with a tricolor ribbon).



### **DURING STAYS**

A) we help with filling in form for the Alien Police

(student need one printing photo). immediately

- **B)** we provide students with the opportunity to **learn in English**.
- **C)** we upload subjects into the electronic system of AIS students. ASIC card (for gratis traveling by train at Slovak Republic) immediately
- D) we inform about student stays on faculty website.

#### Before the end of stay

E) we inform student about online electronic report and its submission by the deadline (student can obtained it as spam email).

**F)** we make a **certificate with graduated subjects** and number of credits from AIS with stamp (in 4 copies). <sup>14</sup>
