



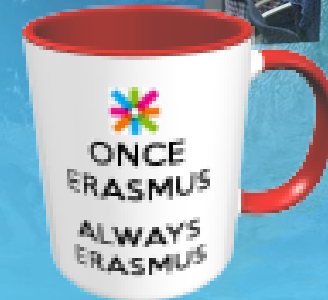

17. The learning outcomes recognition is based on the ECTS*.

Comparison of workload within the framework of academic mobility should be based on a comparison of learning outcomes achieved by student in higher education institution - partner and planned learning outcomes of educational program (curricula) of the home higher education institution.

If the student during the study at higher education institution (research institution) - partner implementing the academic mobility right, has not fulfilled the educational programme, after returning to home higher education institution (research institution), he/she may be asked to schedule individual track to cope with debts or be re-trained at the expenses of physical or legal persons.

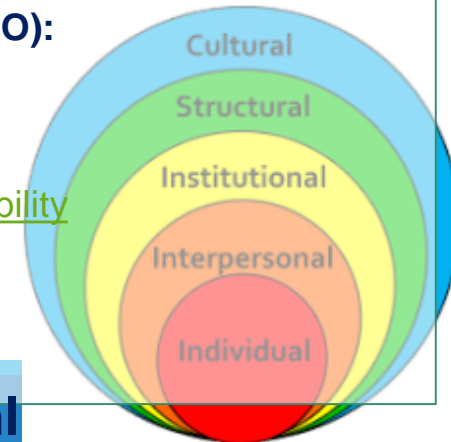

At national level:

Legislation and strategies update (Academic mobility right, visa, permits, international cooperation etc.)

Awareness of the authorities about the challenges/obstacles/problems (inform/ communicate)

Institutional level:

Quality Culture; Integrity culture (in all fields&levels)

Knowledge of the laws and regulations

Implementation of the laws and regulations (development of internal one)

Implementation of the Law of Ukraine “On Higher Education” vs simulation of activities

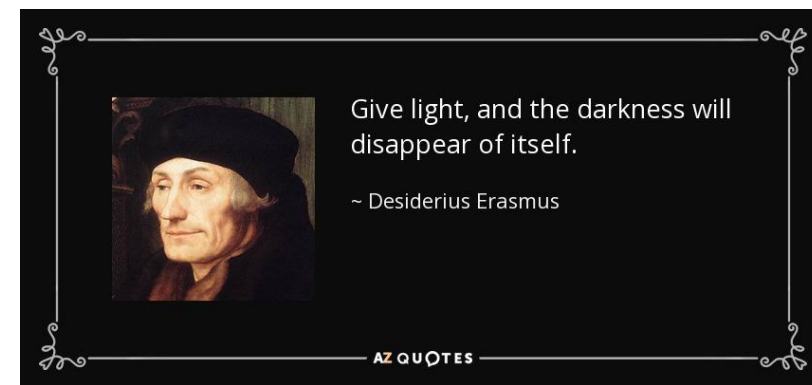
- Autonomy competence (ready to approve internal regulations)
- Modernised curricula on competence based approach with learning outcomes
- Students-centered learning
- Regularly updated ECTS Information Package and its accessibility (courses catalogue)
- QA

Capacities – units, responsible persons trained

Horizontal cooperation and communication: rectors, finance units, deans, lecturers, students – coordinated by the international relation/mobility unit or Erasmus+ contact

Shared responsibility, synergy between teams and projects – complementarity

Leadership, team work and shared responsibility vs management, orders, control and appointment of a guilty staff/student



Be proactive – communicate, discuss and cooperate (at all stages)

Inform national authorities about the challenges and provide suggestions on improvement of legislation



Regular trainings - University leadership, University autonomy, Implementation of Bologna Process tools, Internationalisation, Intercultural communication, Projects management, Recognition, use of the grants etc. (NEO, HERE, British Council, DAAD, projects others)+

- for the staff&students on educational programmes modernisation (Bologna tools on QA – ECTS, DS, NQF etc.) – HERE team events&puplications
- deans and lecturers on recognition tools and mechanisms - HERE team

Communication and guiding staff&students before/during and after mobility (FB, docs, skype, peer learning etc.)
