



- ❖ Projects initially planned and financed by intra-european funding (KA103) within 2014-2020 framework are not eligible to host Ukrainian mobilities.
- ❖ Beneficiaries that have not included Ukraine in their KA107 projects will not be able to make use of the abovementioned flexibility measures.



- ❖ The provided flexibility in terms of regional budget transfers, as well as the adaptation of implementation rules, is foreseen to be extended to KA171 projects of Call 2022 currently under selection.



Spanish HEIs context

Ongoing Projects with Ukraine as Partner country

- ✓ All Spanish projects implementing extraordinary measures will have to take into account that:
- ✓ Adaptations need to be made at the request of project beneficiaries on a voluntary basis.
- ✓ The need of an amendment to the Grant Agreement will be determined by the magnitude of the adaptations in relation to the objectives of the original activity that is being modified and of the project.
- ✓ Some of the activities are authorized before the signature of the amendment.
- ✓ A situation of force majeure invoked by a beneficiary should be assessed on a case by case basis by the authorising officer.
