

About the EU's Programme Erasmus+: 2021-2027

Erasmus+ is the European Union Programme that aims to support the educational, professional and personal development of people in education (school/VET/higher/adult), training, youth and sport, in Europe and beyond through lifelong learning. It contributes to sustainable growth, quality jobs and social cohesion, to driving innovation, and to strengthening European identity and active citizenship. As a key instrument for building a European Education Area, it supports the implementation of the European strategic cooperation in the field of education and training. In addition, it is key in advancing youth policy cooperation under the European Union Youth Strategy and developing the European dimension in sport.

The Programme priorities cover **inclusion and diversity, digital transition, green transition, participation in democratic life, common values and civic engagement**. The Programme provides opportunities for **mobility, scholarships, projects and partnerships for cooperation** between the EU, other countries and Ukraine via annual calls for proposals in formal, non-formal and informal education. It builds professional networks and platforms. The Programme is inclusive and open for individuals of all ages and backgrounds as well as different types of organisations, depending on the calls requirements and projects objectives.

In 2021-2026 Erasmus+ provides opportunities to different types of organisations from Ukraine, within **40 calls for proposals, as a Partner Country not associated to the Programme:**

- International mobility for higher education institutions staff and students (physical/blended)
- International mobility for VET experts (physical/blended)
- International Mobility special measure for Ukraine staff and students of school/VET/Adult institutions
- Learning mobility for youth (13-30 y.o), youth workers and youth participation
- Virtual Exchanges for higher education and youth (COILs)
- Erasmus Mundus Joint Programmes (projects and scholarships)
- Capacity Building Actions in Higher Education, in VET, in youth, in sport (staff/content/infrastructure)
- Jean Monnet (teaching/research/platforms)
- Cooperation Partnerships for Innovations for schools /VET/ higher/ adult education/ youth/ sport
- European Universities and Alliances for Innovations Actions
- European Policy Experimentation and Forward Looking Partnership
- Open resources, networks and support offices: Erasmus+, European School Education Platform, eTwinning, European Youth Platform, Europass, Euroguidance, Eurydice, Youthpass, Eurodesk, EQF, EPAL, LifeLongLearning, SELFIE, Salto Education and Training, Salto-Youth and others etc.

The European Commission co-funds projects via grants to **organisations** from EUR **35,000** to EUR **4M** depending on the types of the calls and projects duration (**1-4 years**).

Individuals can apply to mobility projects and receive grants for traineeship or credit mobility (EUR **900 per month**), degree mobility, (EUR **1000** per month plus travel and other expenses), teaching, training and job shadowing, participation in the international youth events and activities etc. International students and young people from abroad could benefit too and come to Ukraine for exchange mobility etc.

The projects budgets covers human resources development, teaching and learning excellence, staff costs, mobilities for exchange, study missions, training of trainers, innovative curricular, training courses and resources, summer/winter camps, methodologies, technologies and infrastructure development (equipment), translation, publications, scholarships and individual grants, all depends on the call.

Depending on action, the partnerships may include a **single organisation from Ukraine or more, 2 or more organisations from EU Member States and other participating countries over the world**. The cooperation is based on the learning the EU expertise and exchanging of best practices between different countries in the Programme fields: education, training, youth and sport.

Supporting Ukrainians and organisations under Erasmus+, 2022 till now by the European Commission:

1. International Mobility projects under KA1:

Over **51 680 Ukrainian nationals** participated in Erasmus+ International Mobility projects since 2022, whether coming from Ukraine or from any Programme country, with a total granted amount of **EUR 129 million (including EUR 32 million for KA171 mobilities)**. Out of these 51 680 mobilities, **34 489** originated from Ukraine since 2022, for a total grant amount of **EUR 98 million**.

2. Cooperation projects KA2:

Since 2023, Erasmus+ includes a priority to projects aiming at addressing the consequences of Russia's war of aggression against Ukraine in the education and training , youth and sport sectors.

Under indirect management by the National Erasmus+ National Agencies (KA220 calls), grants supporting this priority have amounted to EUR **48 million since 2023**.

Under direct management (by EACEA, Brussels), since 2022, Ukrainian organisations contracted grants amounting to **EUR 22.3 million**, under Capacity building for higher education, VET, youth and sport.

3. **KA3 and Jean Monnet actions:** Ukrainian organisations contracted grants amounting to **EUR 9.3 million** since 2022 for European Studies.

In total, Erasmus+ support for Ukrainians and Ukrainian organisations since 2022 has amounted to over EUR 208 million.

Due to sanctions and termination of Russia and Belarus participation in Erasmus+, their budget was relocated, providing more Ukrainian projects funding.

Ukraine under Erasmus+ 2021-2026

Organisations working in education, training, youth and sport fields of Ukraine benefit from participation in different actions of Erasmus + Programme. Ukraine has the biggest number of projects in the Neighbourhood East Region 2 and is among the top twelve Participating Countries of the Programme.

In figures, particularly in 2021-2026, the EU's Erasmus+ Programme funded the following actions:

- **22 799** international mobilities for Ukrainians' Universities staff & students within **1443** projects in cooperation with **33** Programme Countries based on the bilateral interinstitutional agreements;
- **1 450** projects with **7 896** learning mobilities grants for young people (13-30 years old), youth workers and active citizenship exchanges;
- **15** Virtual Exchanges projects in higher education and youth (grants up to EUR 500,000 per project);
- **18** Erasmus Mundus Joint Masters Design Measures (EUR 65,000) and Joint Masters Programmes implementation (EUR 2,8 M per project);
- **167** Erasmus Mundus Joint Master Degree students scholarships provided to Ukrainians;
- **259** Cooperation Partnerships projects in education, training, youth and sport (grants from EUR 35,000 to 500,000 per project);
- **8** projects of Alliances for Innovations with Ukrainian industries, VET and HEIs as partners (grants EUR 4M per project);
- **5** Centers of Vocational Excellence (EUR 4 M per project);
- **68+2** projects on Capacity Building in Higher Education (grants from EUR 200,000 to 1M per project);
- **15** projects on Capacity Building in VET (grants from EUR 100,000 to 400,000 per project);
- **17** projects on capacity building projects in youth (grants from EUR 100,000 to 300,000 per project);
- **12** projects on capacity building projects in sport (grants from EUR 100,000 to 200,000 per project);
- **273** Jean Monnet (European Studies) projects (grants from EUR 35,000 to 100,000 per project);
- Creation of Digital University Ecosystem in Ukraine (EUR 5M);
- **32** HEIs and **2** other organisations that have joined 34 European Universities Alliances and working together on the challenges in higher education in Europe as associated partners;
- **Erasmus Students Network and Erasmus Mundus Alumni** are active in Ukraine;
- **13 Higher Education reform experts (HEREs)** supported by Erasmus+ Programme coordinated by the **National Erasmus+ Office – Ukraine**;
- In 2024-2025: **946** new eTwinners were registered at the Platform, **250** new education institutions from Ukraine, Ukrainian participants joint **727** projects, **227** eTwinning-projects were awarded with National Quality Label, **145** – with European Quality Label; 6 schools received eTwinning School Label, after reopening of the **National eTwinning Support Office in Ukraine**. Since 2013-2026 – **1,6 thousands** education institutions received access to European School Education Platform functioning under Erasmus + Programme, **4,3 thousands** individual profiles;
- In 2023, EU Erasmus + Programme funded printing of **500,000** schoolbooks on Ukrainian language. In 2024, it is **1** million textbooks printed by the EU on informatics and arts for 5th and 6th grade students. So far, EUR **3** million has been earmarked by the Erasmus+ Programme for this action, and talks are already ongoing with the Ukrainian authorities on a third batch of copies for the next school year.

Moreover, Erasmus+ continues to be a unique Programme and Eurointegration instrument of EU with a systemic impact on reforms in education, training, youth and sport. It contributes to the capacity building of institutions and establishing a long term cooperation communities working in these fields to join smoothly the European Education Area and converge with the European standards. It results into the high profile and quality value-based Erasmus Generation as Ambassadors, agents of change, Eurointegrators and negotiators during Ukraine's accession to EU and rebuilding Ukraine and building European future together.
