# What are the FV for?

- Address the crisis of academic freedom in Europe
- The "values" avenue short term tactic or long-term moral engagement.
- Final port is legal? EHEA members commitments: protect and promote.
- Not just academic freedom.
- Create a common although complex/multiple framework of reference (legal too?)
- Protect and promote the FV, the main function of higher education (technical) and also democracy

# Who are the FV for?

- Governments, not higher education organizations?
- Obligations and rights, for what stakeholders
- What can/must governments do?
- When can/must universities/universities communities/constituencies do.?
- What about other stakeholders.

# What does it mean to focus on the FV?

- Major potential Impact of the Bologna Process
- New/special focus on values
- Focus on governance, not teaching and learning, and research? Not structure of degrees, social dimension, QA, etc.?

- What other relevant paraments




- Should Ukraine focus on Values?
